

INVITATION TO APPLY FOR ELIGIBILITY AND PREQUALIFY ("IAEP")

Metro Pacific Dumaguete Water Services, Inc. now invites interested bidders to apply for eligibility and prequalify for the bidding of the herein described project, as follows:

Name of Project

: Construction of Perimeter Fence at Talay Warehouse/Pumping Station 1

Location

: Talay, Dumaguete City

Brief Description

: The project includes supply of materials, labor, tools and equipment related to providing a new perimeter fence with a total coverage length of 188 meters, demolish the existing fence foundation and build a new fence including foundation and provide concealed conduits embedded within the perimeter fence.

Approved Budget for the Contract (ABC): Php 4,852,993.44

Contract Duration: 8 months

Bidding will be conducted through open competitive bidding procedures. Bids received in excess of the Approved Budget for the Contract (ABC) shall be automatically rejected at bid opening.

Bidders should have completed a contract similar to the Project within five (5) years prior to the date of submission and receipt of bids. Bidders should likewise be duly licensed by the Philippine Contractors Accreditation Board (PCAB).
