



INVITATION TO APPLY FOR ELIGIBILITY AND PREQUALIFY (“IAEP”)

Metro Pacific Dumaguete Water Services, Inc. now invites interested bidders to apply for eligibility and prequalify for the bidding of the herein described project, as follows:

Name of Project : Upgrade of PS 20 Receiving Pipeline Phase 1 and 2

Location : Brgy. Buñao, Dumaguete City

Brief Description : The project includes supply of labor and materials for the upgrading of the receiving pipeline from 2-1/2” and 6” to 10”. The receiving pipeline that will be upgraded have a total length of 2,395 meters with Phase 1 at 1,073 meters and Phase 2 at 1,322 meters. The upgraded receiving pipe will incorporate standard elements such as the air relief valve, blow-off, and emphasizing the standard application for pipe cross-over.

Approved Budget for the Contract (ABC): Php 27,429,637.22

Contract Duration : 6 months

Bidding will be conducted through open competitive bidding procedures. Bids received in excess of the Approved Budget for the Contract (ABC) shall be automatically rejected at bid opening.

Bidders should have completed a contract similar to the Project within five (5) years prior to the date of submission and receipt of bids. Bidders should likewise be duly licensed by the Philippine Contractors Accreditation Board (PCAB).

A complete set of the IAEP prequalification documents may be acquired by interested bidders from **February 21 – 28, 2022** from the address given below and upon payment of non-refundable fee in the amount of **Eight Thousand Pesos Only (Php 8,000.00)**. Prequalified bidders shall be given the Bidding Documents at no additional cost. **Bidding Documents will be available from March 04 – 10, 2022.**

Metro Pacific Dumaguete Water Services, Inc. will hold a Pre-Bid Conference on **March 11, 2022 (03:00 PM)** at **Metro Dumaguete Water Level 3 Board Room, DCWD Office Building, Circumferential Road, Barangay Daro, Dumaguete City.**

Bids must be submitted on or before **March 18, 2022 (03:00 PM)** to the address given below. All bids must be duly accomplished as stated in the Bidding Documents Section II: “Instruction to Bidders (ITB)”. Late bids shall not be accepted.


