

**INVITATION TO APPLY FOR ELIGIBILITY AND PREQUALIFY (“IAEP”)**

**Metro Pacific Dumaguete Water Services, Inc.** now invites interested bidders to apply for eligibility and prequalify for the bidding of the herein described project, as follows:

**Name of Project** : **Supply of Labor, Materials, Tools, and Equipment for the Implementation of Transmission Line Phase 5A**

**Location** : **Dumaguete City, Negros Oriental**

**Brief Description** : **The scope of work will include the supply of labor, materials, tools, and equipment for the implementation of Transmission Pipeline Phase 5A (D= 250mm or 10”; L= 988m). Detailed activity consists of General Requirements, Pavement Cutting, Breaking and Surface Restoration, Pipelaying Installation, Appurtenances, Interconnection Works and Testing and Commissioning.**

**Contract Duration** : **6 months**

Bidding will be conducted through open competitive bidding procedures.

Bidders should have completed a contract similar to the Project within five (5) years prior to the date of submission and receipt of bids.

Bids must be submitted on or before **July 22, 2024 (2:00 PM)** to the address given below. All bids must be duly accomplished as stated in the Bidding Documents Section II: “Instruction to Bidders (ITB)”. Late bids shall not be accepted.
